I acknowledge and agree that I have no right to review or approve Materials before they are used by Kiwanis, and that Kiwanis has no liability to me for any editing or alteration of the Materials or for any distortion or other effects resulting from Kiwanis's editing, alteration, or use of the Materials. Kiwanis has no obligation to use the Materials or to exercise any rights given by this Agreement.

To the fullest extent permitted by applicable law, I hereby irrevocably waive all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages, and expenses, including but not limited to claims for copyright or trademark infringement, infringement of moral rights, defamation, invasion of rights of privacy, rights of publicity, intrusion, false light, public disclosure of private facts, physical or emotional injury or distress, or any similar claim or cause of action in tort, contract, or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, "**Claims**") arising directly or indirectly from the exercise of my rights under this Waiver and Release and the use and exploitation of the Materials, and whether resulting in whole or in part by the negligence of Kiwanis or any other person, covenant not to make or bring any such Claim against Kiwanis, and forever release and discharge Kiwanis from liability under such Claims.

All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the internal laws of the State of California. I represent and warrant I am duly authorized and have authority to execute this Agreement on behalf of the grant recipient named below.
